

## **Computer-Based Testing FAQs for CDT Written Examinations**

In order to offer a greater number of testing locations and more flexible scheduling, NBC administers the CDT and RG written examinations utilizing computer-based testing with remote proctoring. The examinations are delivered through the computer-based testing platform, FastTest, and are remotely proctored by the third-party proctoring service, MonitorEDU.

- How much does it cost to take the examinations? Computer-based testing for the RG Examination, Comprehensive Examination, and Written Specialty Examinations are each \$255.00.
- What will candidates need in order to take the examination?
  - Private workspace (a busy location, such as a library or café, will not suffice)
  - Desktop computer or laptop computer with Internet capabilities that meets the requirements for FastTest as outlined in the link below:

  - Cellular smart phone that meets the requirements for MonitorEDU as outlined in the link below:

  - o Power cords for desktop computer/laptop/tablet and cellular smart phone
  - Something to prop thier cellular smart phone on (tripod, phone stand, household item, etc.)
  - o Photographic identification (Driver's License or Passport)
  - A printed copy of their NBC candidate letter
- How do candidates apply for the examinations using the computer-based testing option? Applications can be completed directly online or by mailing, emailing, or faxing in a hard copy application. All applications can be found on the NBC website at <a href="https://www.nbccert.org/become-a-cdt">www.nbccert.org/become-a-cdt</a>.
- What are the application deadlines for computer-based testing?
  - Testing windows run from the first day of each month through the last day of each month. Application deadlines are the **20**<sup>th</sup> **of the month prior** to the desired testing window. (For example, if a candidate wants to take their examination in August, they must submit their application to NBC by July 20<sup>th</sup>.)
- How long do candidates have to take their examination once their application is approved by the NBC?
  Testing windows run from the first day of each month through the last day of each month. The day and time within the window is entirely up to the candidate there is **no pre-scheduling** once approved.
- Are there any restrictions on the time of day that candidates can take their examination?
  No. Examinations can be taken at the candidate's desired time, 24 hours a day, 7 days a week within their approved testing window.
- What happens if candidates do not test during their approved testing window?
  If a candidate does not complete their written examination during their testing window, they will forfeit all payment, and may be rescheduled for another examination upon re-payment. No refunds will be given.

- > Are candidates able to reschedule their examination to another monthly testing window?
  - Candidates may reschedule their examination to a different testing window than originally outlined within their application at no charge by notifying the NBC in writing prior to the published application deadline.
     Initial fees paid must be used within one year; otherwise, the candidate will forfeit all fees paid to NBC and must re-apply to complete the examination.
  - Candidates that fail to notify the NBC in writing prior to the published application deadline must get special permission from the NBC to reschedule to a different testing window. If allowed to do so, candidates will be charged a \$25 administrative fee for each written examination, which must be paid prior to the candidate being rescheduled.
- Will candidates receive their examination grade immediately after testing?
  No. Candidates will be mailed their grades within four weeks after the examination. Candidates may also opt to receive their grades by email when completing the application.
- Can candidates still take the written examinations in-person at a location scheduled by the NBC?
  No. The written examinations are no longer offered in-person using the paper-based testing option.
- Do candidates still have to take the Practical examination at a location scheduled by the NBC? No. The Practical examination is offered **both** remotely using a third party proctor as well as in group testing format at a pre-scheduled volunteer host site.
